YOUR CHILD'S ENTITLEMENT TO FREE EARLY LEARNING AND CARE

15 HOURS FREE EARLY LEARNING AND CARE

All eligible three and four year olds are currently entitled to 15 hours free early learning and care per week, for 38 weeks per year.

In our school we offer 15 hours free early education per week, for 38 weeks (term time) per year. This is currently offered as 5 x 3 hour sessions per week.

You can choose from morning OR afternoon places.

The morning sessions run 8.30am-11.30am.

The afternoon sessions run 12.30-3.30pm.

30 HOURS EXTENDED ENTITLEMENT

Some three and four year olds are eligible to a funded early years place of 30 hours a week. Details of requirements for eligibility for this funding can be found at <https://www.childcarechoices.gov.uk>

In our school a limited number of full day (30 hour) spaces (term time) are available which will incur a cost for the lunchtime period (Please see details in our Nursery Admissions policy)
